1. ORGANIZER AND AUCTION SUBJECT

3. AUCTION TERMS AND CONDITIONS

- 3.2. The auction item can be viewed at the headquarters of the Polanex sp. z o. o. branch in Łódź, ul. Szparagowa 6/8, 91-211 Łódź Poland from August 30, 2024 to September 12, 2024 from from 900 AM to 200 PM after prior arrangement at the telephone numbers provided below.
- 3.3. The condition for participating in the auction is to pay a deposit within the deadline specified in point 4.1. The date of submitting the deposit is considered to be the date of receipt of the deposit amount to the indicated bank account of Polanex sp. z o. o.
- 3.4. The deposit submitted by bidders whose offers are not selected will be returned within 7 business days after selecting the offer, closing the auction without selecting the offer or invalidating the auction.
- 3.5. The cash deposit submitted by the buyer will be counted towards the purchase price.
- 3.6. The deposit will be forfeited to Polanex sp. z o. o. if none of the auction participants offers the starting price.
- 3.7. The condition for participating in the auction is also the submission of the declarations and documents required by this announcement.
- 3.8. The auction is won by the bidder who offered the highest price during the auction.
- 3.9. Upon acceptance, the buyer is obliged to conclude a sales contract with Polanex sp. z o. o.
- 3.10. The buyer will be obliged to pay the purchase price to the bank account indicated by Polanex sp. z o. o. no later than 5 business days from the date of conclusion of the sales contract.
- 3.11. The sale item will be handed over to the buyer immediately after payment of the purchase price and conclusion of the sales contract, which may also be conditional on Polanex sp. z o. o. obtaining appropriate corporate consents and consents of Polanex sp. z o. o.'s creditors to release the encumbered sale items.
- 3.12. The deposit will be forfeited to Polanex sp. z o. o. if the buyer whose offer is selected does not proceed to conclude the sales contract due to his own fault.

- 3.13. The deposit will be forfeited to Polanex sp. z o.o. also if the buyer fails to pay the purchase price within the required period and does not conclude the sales contract within the specified period by Polanex sp. z o.o.
- 3.14. Polanex sp. zoo has the right to close the auction without selecting an offer and without giving a reason.
- 3.15. Polanex sp. z o.o. has the right to cancel the auction without giving a reason.
- 3.16. Polanex sp. z o.o. has the right to change or cancel the announcement and auction conditions.
- 3.17. Due to non-admission to the auction, failure to select an offer, or closureauction without selecting the offer or canceling the auction, the bidder is not entitled to any claims against Polanex sp. z o.o.
